#### APPLICANT SELECTION CRITERIA

Eligible applicants will be assessed according to a 100-point scale. The top 12 applicants will be accepted for admission.

**ADMISSIONS POINT SYSTEM** – Eligible applicants will be assessed according to the following point system:

- 1. <u>Prerequisite GPA of a 2.75 or better:</u> A maximum of **50 points** will be awarded. The applicant must provide transcript(s) from an accredited college or university for all prerequisites. Prerequisites will be calculated in the GPA for assignment of points in the admission process. Official transcripts submitted to TMCC for coursework to be assessed are necessary for application purposes. All prerequisites must have been passed with a C or better.
- 2. <u>Brief Narrative Statement:</u> A maximum of **25 points** will be awarded. A summary of your educational/work experiences and how those experiences will help you progress through your nursing courses. Please include your reasons on wanting to become a nurse. Limit the narrative to two (2) typed pages using Times Roman Font #12. Your writing ability including grammar and spelling will be evaluated.
- 3. <u>Provide two letters of Recommendation Statements:</u> A maximum of **15 points** will be awarded. These statements must come from a current or former employer and one college instructor. These references must be the original reference, with original signatures.
- 4. <u>Successful Interview:</u> A maximum of **10 points** will be given for applicants professional appearance, communication/grammar and the ability to answer questions appropriately related to application criteria.

TMCC Nursing Department reserves the right to change or update the areas to be assessed as necessary.

#### Admission criteria include:

- 1. Meet all TMCC admission requirements.
- 2. Completed application form.
- 3. Must have all pre-requisites completed (BIOL 220 & 221 Anatomy and Physiology I & II must have been completed within the last five years).
- 4. Must include all other nursing schools attended. Failure to list these schools may result in dismissal from the program.
- 5. Must have all official transcripts on file at the registrar's office.
- 6. Have a cumulative GPA of 2.75 or better on all required pre-requisite courses.
- 7. Must have a 'C' or better in all pre-requisite courses.
- 8. Brief narrative statement of no more than 2 typed pages.
- 9. TEAS score at or above the "Proficient" cut score
- 10. Successful interview process.
- 11. All applicants must have current C.P.R. certification. Proof of certification must be provided to the nursing department with application.
- 12. Current Certified Nursing Assistant (C.N.A.).
- 13. All applicants must show proof of current immunizations including MMR, TB, Hepatitis B, Chicken Pox.

Applications received after the designated date will be only considered if there is space available. Students will be notified in writing of their admission status. In addition, the admission notification will be forwarded to the TMCC admissions officer. Students are required to sign and return the "Letter of Intent of admission to the TMCC AASPN program" within 2 weeks of notification of admission to the nursing program.

Completing the application process does not guarantee admission to the nursing courses. The total numbers of students in the courses are limited by availability of clinical experiences and available faculty. In the case of an excess of qualified applicants, grade point average will be considered in making the decision as to which students will be accepted into the courses. Qualified late applicants will be admitted to nursing courses on a space available basis.

The program of study was designed based on TMCC's institutional mission, philosophy and goals with integration of the AASPN program goals and objectives. It incorporates TMCC's basic curriculum for Associate of Applied Science degree. The curriculum is designed to meet the North Dakota State Board of Nursing Standards for Nursing Education Programs. The graduate of this program is eligible to write the national examination for licensing as a licensed practical nurse (NCLEX-PN).

#### **Health Requirements:**

The following immunizations/tests/certifications must be completed prior to admission to the Nursing Program. Documentation must be on a health care agency form and signed by a licensed healthcare professional. All doses must be valid.

Failure to update the health verifications will result in failure to continue in clinical.

**Hepatitis B Immunization:** 3 doses (at least the first dose given prior to admission), along with post-vaccination serologic testing required, which is considered the titer. Students may sign a waiver of declination to be vaccinated and/or to complete the post vaccination serologic testing.

High-risk adults which includes health care workers should be vaccinated. Risks are often highest during the professional training period. Therefore, vaccination should be completed during training before trainees have contact with blood or other potentially infectious materials.

Three doses of Hepatitis B vaccine are needed. All nursing students must provide post-vaccination, serologic testing for a response to the Hepatitis B vaccine, even if the series was completed prior to December of 1997. Post-vaccination testing should be performed 1-2 months after completion of the vaccine series. However testing will be required even if the interval between the completion of the series and the post-vaccination serologic testing is greater than 2 months. Persons who are determined to be non-responders should be counseled by their health care providers.

<u>Measles, Mumps & Rubella (MMR)</u>: 2 doses. No vaccination required if born before 1957. (Usually considered immune but not a guarantee, vaccination is recommended).

Adults in high-risk groups, such as health care workers, should receive a total of two doses. Adults born before 1957 are usually considered immune, but proof of immunity may be desirable. A recommendation of a dose of MMR vaccine to unvaccinated students born before 1957 should be considered. Students with or without patient-care responsibilities, who are measles or rubella susceptible, can contract and transmit these diseases.

Students known to be pregnant or attempting to become pregnant should not receive the rubella vaccine. These students should be counseled by their health care professional regarding attendance at classes.

<u>Varicella (Chickenpox) Immunization:</u> No vaccination required with a reliable history of the disease. 1 dose if vaccinated before age 13 years or 2 doses if vaccinated at 13 years of age or older.

All susceptible adults should be vaccinated, especially nursing students who have close contact with persons at high risk for serious complications. Students with reliable histories of chickenpox (such as



self or parental report of the disease) can be assumed to be immune. Students who have no reliable history may choose to have serologic testing.

<u>Tuberculin testing</u>: Upon admission, students must provide documentation of a negative two step TB test (or 2 negative TB tests). The second step should be administered between one and three weeks after the first test. Thereafter students must submit a negative TB test annually.

Students who are positive reactors must have a report of one negative chest x-ray on file and a statement signed by self and a health care provider, assuring absence of symptoms.

<u>Cardio-Pulmonary-Resuscitation Certification (CPR)</u>: Students must maintain current verification of CPR certification preferably by the American Heart Association in Basic Life Support. Certification training must include infant, child, and adult CPR as well as both 1 and 2 person CPR. Written documentation must include the expiration date of current certification.

Health Insurance Portability & Accountability Act (HIPAA) training will be conducted during the first semester in nursing.

Varicella (Chickenpox) Immunization: No vaccination required with a reliable history of the disease. 1 dose if vaccinated before age 13 years or 2 doses if vaccinated at 13 years of age or older.
